# 2020 offers opportunities

The year 2019 was historic from an investing perspective. The Dow 30 Industrials index was up over 25%; the S&P 500 index was up over 31%; and the NASDAQ index was up over 30% in 2019. Were you happy with your investing results for 2019? What are your investing plans for 2020?

The investing forecast for 2020 is good. Many experts in 2019 were calling for a recession that didn't materialize. Many also believe that, given the three rate cuts by the Federal Reserve in 2019, the necessary and sufficient stimulus has been injected into the U.S. economy to stave off a recession for at least 12 months.

Several research groups have indicated that while a couple of signals point to a recession (such as an inverted yield curve), there are several other indicators (including unemployment), that point to not even being close to a recession.

Trade tensions between the U.S. and China have eased. On January 15, 2020, the U.S. and China signed "phase one" of a trade deal. The significance, besides reducing tariffs and increasing trade between the two nations, is the signal for

increased cooperation and future agreement on trade.

Also, 2020 is an election year with the U.S. House of Representatives, one-third of the U.S. Senate, and the office of President of the United States. The potential for change is dramatic, and the crystallization of that potential will become clearer on the first Wednesday of November 2020.
