## When will I be able to access my Year End tax forms in online banking?

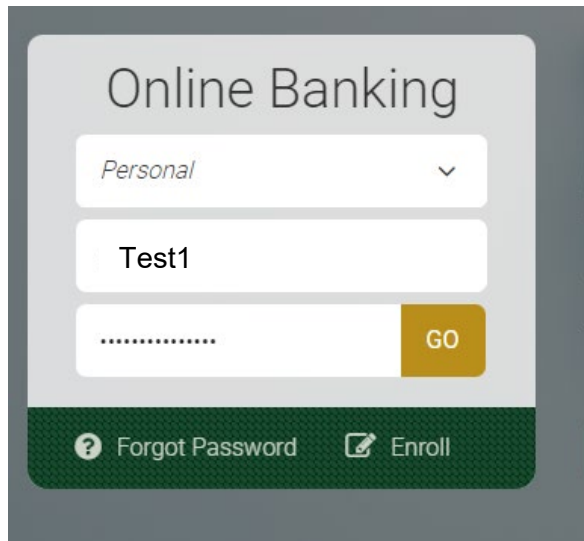
Year End tax forms are available as of January 15, 2025 in FMUB's online banking platform.

Farmers & Merchants Union Bank will also be mailing all Year End tax forms by January 31, 2025.

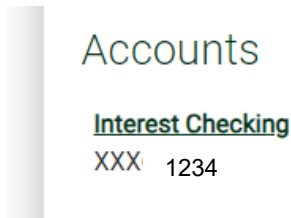
## How do I access my Year End tax forms from online banking?

You can access your Year End tax forms with Farmers & Merchants Union Bank Online Banking platform with these five easy steps:

1. Log-in to FMUB online banking
  - Tax documents are **NOT** available in FMUB's mobile banking app or Business Online Banking



2. Choose the account you wish to view the tax document for from your dashboard



- 3. On the account screen, choose the Documents button

**What types of tax forms can I see in FMUB's online banking?**

When you are in the Documents screen for your account with FMUB and go to the Document Type dropdown option, you will see the following options:

- 1099-INT - interest income earned statements, for checking, savings and certificate of deposit (CD) accounts; please note that if you had less than \$10 of interest from FMUB in 2024, you will not receive a 1099-INT, these forms are only required when you earn more \$10 or more of interest
- 1099-R - statements for IRA (Individual Retirement Account) distributions (traditional and ROTH)
- 1099-SA - statement for HSA (Health Savings Account) distributions
- 1099-DIV - statement for dividends
- Year End Loan statements – 1098-sub forms for customers who paid interest on mortgages, Home Equity Lines of Credit (HELOC) or consumer construction loans and other year-end loan statements

Please note that you will see all of these options, even if they don't apply to the types of accounts you have with Farmers & Merchants Union Bank. When the bank started offering these forms to be available electronically, we had to turn all options on for all customers. If you have the correct accounts for the corresponding forms, you will have a populated form. If you chose reports that don't apply to you, when you click on one of them, you will get a response that says o – No Documents Available.

### **Can I view these tax statements for my business account as well?**

At this time, Farmers & Merchants Union Bank only has this feature available for consumer accounts.

### **Can I get these documents in my FMUB mobile app?**

Unfortunately, at this time, electronic copies of your Year End tax forms are only available in FMUB's online banking platform.

You can access FMUB online banking from a PC, tablet or mobile device. However, if you use your mobile device, keep in mind you will have to use your devices' web browser to visit [fmub.bank](http://fmub.bank) and utilize the online banking log-in area.

Farmers & Merchants Union Bank will also send a hard-copy of all Year End tax forms in the mail by January 31, 2025.

### **I'm logging in to FMUB's online banking but I can't see my forms, why not?**

If you are the secondary signer on the account, you will not be able to see tax forms under your log-in credentials. Tax forms will only be viewable under the FMUB login credentials for the primary account holder whose tax payer identification number appears on the form.

### **Will Farmers & Merchants Union Bank still mail me a hard copy of these tax forms?**

YES, Farmers & Merchants Union Bank will still send hardcopies of all Year End tax forms to all customers via the United States Postal Service, regardless if you access these forms through online banking.

This new way of accessing your forms is for your convenience if you misplace your mailed copy, need an additional copy or wish to view them before they arrive in the mail.

Your forms will be mailed by January 31, 2025 and you can always contact one of Farmers & Merchants Union Bank's six convenient locations if you need additional copies.

### **When I log-in to FMUB online banking, go to my accounts and documents, I see Year End 5498-Sub and Year End 5498-SA as an option. When I click, nothing happens. Is there something wrong with my account?**

NO, there is nothing wrong with your account if you click these forms and they do not populate. These forms are for Individual Retirement Account (IRA) and Health Savings Account (HSA) reporting and they should not have any information populated in them until May.

### **What do I do if I feel there is misinformation on my Year End tax forms?**
